

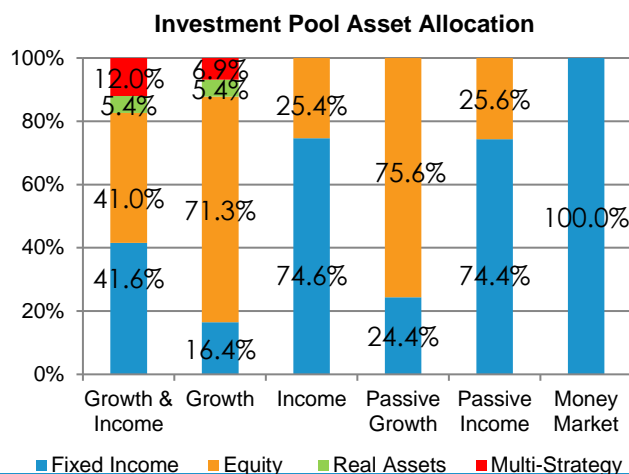


## Monthly Market Update

- Domestically, equity markets produced positive results in the mid-single digits; large cap stocks trailed their small cap counterparts for the month and have now fallen behind year-to-date. International developed markets also saw gains, with returns slightly ahead of domestic equity markets for the month, but well behind for the year. Emerging markets also continued to rise, with performance in line with developed markets. Year-to-date, it remains the top performing segment of the equity market.
- Within fixed income, falling interest rates and credit spread compression led to gains for the asset class. Credit, specifically high yield, turned in an excellent quarter, outpacing Treasuries by a wide margin, as an overall risk-on market tone led to tighter spreads.
- Real Asset markets were mixed in July with the *Bloomberg Commodity Index* (-5.1%) falling as the *Dow Jones Global Listed Infrastructure* (+1.2%) rose.

## Asset Allocation Summary

- **Growth Pool (+3.3%)** matched its custom benchmark and led its simple benchmark by +40 bps. Global equity managers led the MSCI ACWI by +120 bps.
- **Passive Growth Pool (+3.0%)** lagged its custom benchmark by -50 bps but led its simple benchmark by +10 bps.
- **Growth & Income Pool (+2.4%)** led both its custom and simple benchmarks by +20 bps. Long/short fixed income managers performed well, led by Chatham.
- **Income Pool (+1.9%)** led both its custom and simple benchmarks by +20 bps and +50 bps, respectively. Long/short fixed income managers aided performance.
- **Passive Income Pool (+1.3%)** trailed both its custom and simple benchmarks by -40 bps and -10 bps, respectively.

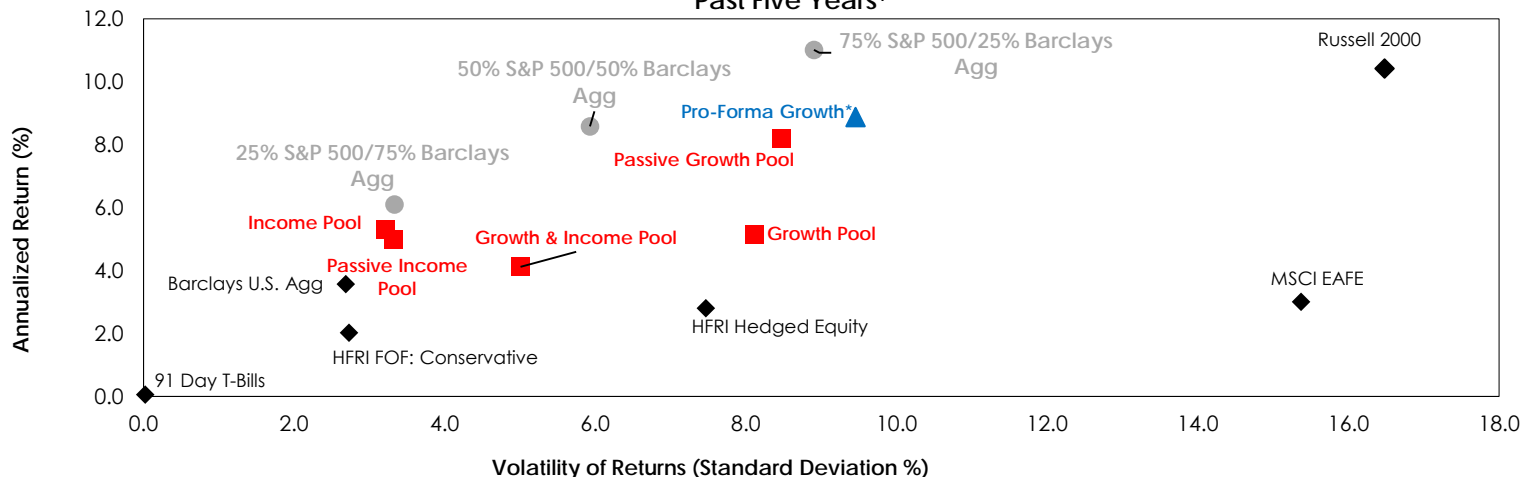
