



Investments Pool Update: Month of March 31, 2017

Markets

- The trend of strengthening global economic data and growth continued through March, and equity markets, particularly within developed international and emerging economies, performed strongly. The Trump-inspired domestic equity rally that began in November lost steam in March, as policy setbacks raised concerns over the new administration's ability to implement its agenda, however, major domestic equity indices still eked out gains. Returns were much more robust abroad, with both developed and emerging markets producing gains on the back of an improving global growth story.
- In light of strengthening economic growth, the U.S. Federal Reserve raised the Fed Funds rate 25 basis points (bps) in March, a move markets took in stride, as it was fully expected and priced into the market in the days leading up to the Fed meeting. Interest rates ticked higher in March, which was a headwind for fixed income indices, though the small setback did not prevent fixed income markets from finishing the quarter with positive results overall.
- Real asset markets were mixed in March with the *Bloomberg Commodity Index* (-2.7%) and *DJ Brookfield Global Infrastructure Index* (+2.6%).

Performance Commentary for Pools, Past Month

Moderate-Term Pool:

- **The Growth & Income Pool rose +0.6%**, matching its custom benchmark. The strong relative performance of long/short equity managers was offset by the relative performance of multi-strategy managers.

Long-Term Pools:

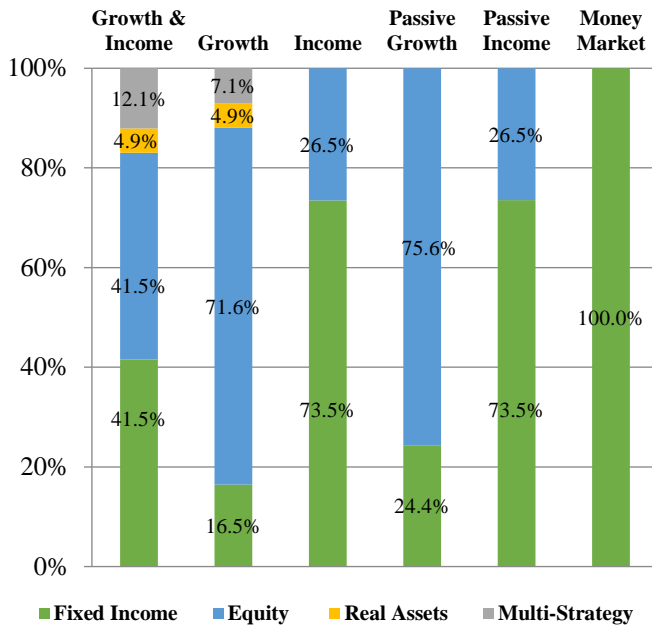
- **The Growth Pool rose +1.0%**, outperforming its custom benchmark by +10 bps due in part to global equity managers continuing to outperform as they have throughout the quarter.
- **The Passive Growth Pool rose +0.6%**, and led its simple benchmark slightly by +50 bps.

Shorter-Term Pools:

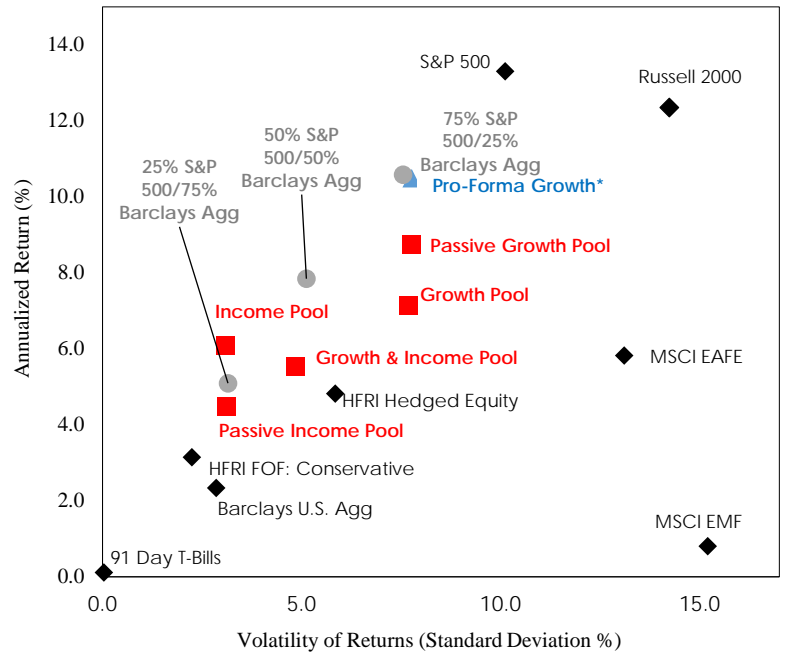
- **The Income Pool rose +0.2%**, matching its custom benchmark. While long/short fixed income managers matched their peers this month, they trailed the global fixed income benchmark.
- **The Passive Income Pool rose +0.2%**, and led the performance of its simple benchmark by +20 bps.
