



Investments Pool Update: Month of December 31, 2017

Markets

- Equity markets rallied further in December with newly passed tax reform measures, which, among other changes, lower the corporate tax rate and are expected to enhance corporate earnings. International equity markets also performed well, outpacing domestic equities. Emerging markets performed best as commodity prices increased and the U.S. dollar weakened.
- Fixed income markets also advanced, albeit modestly. Given the generally healthy economic backdrop, corporate spreads tightened and spread product sectors outpaced government securities.
- Real asset markets were mixed in December as the *Bloomberg Commodity Index* rose +3.0% and the *DJ Brookfield Global Infrastructure Index* fell -0.2%.

Performance Commentary for Pools, Past Month

Moderate-Term Pool:

- **The Growth & Income Pool rose +0.8%**, but trailed its custom benchmark. Outperformance from the multi-strategy composite was offset by underperformance from the equity and fixed income composites.

Long-Term Pools:

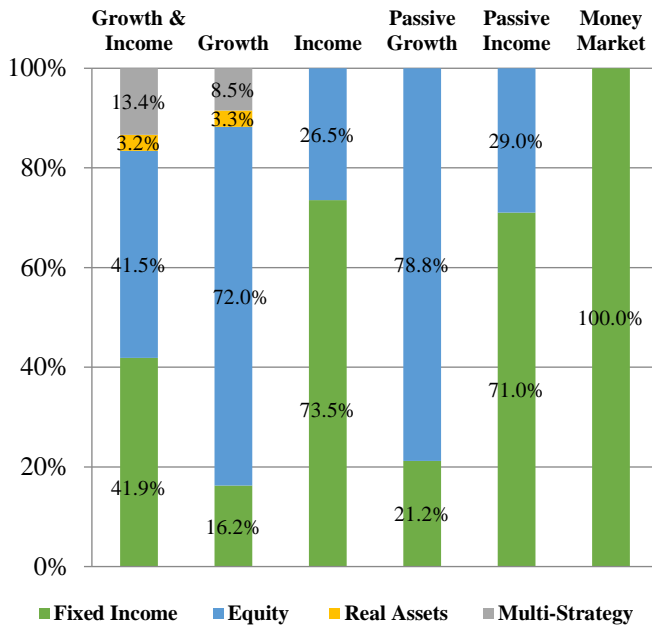
- **The Growth Pool rose +1.2%**, and trailed its custom benchmark by -0.1%. An overweight to domestic large cap equity manager Adage, which trailed the S&P 500 this month, detracted from performance.
- **The Passive Growth Pool rose +1.1%**, and led its simple benchmark.

Shorter-Term Pools:

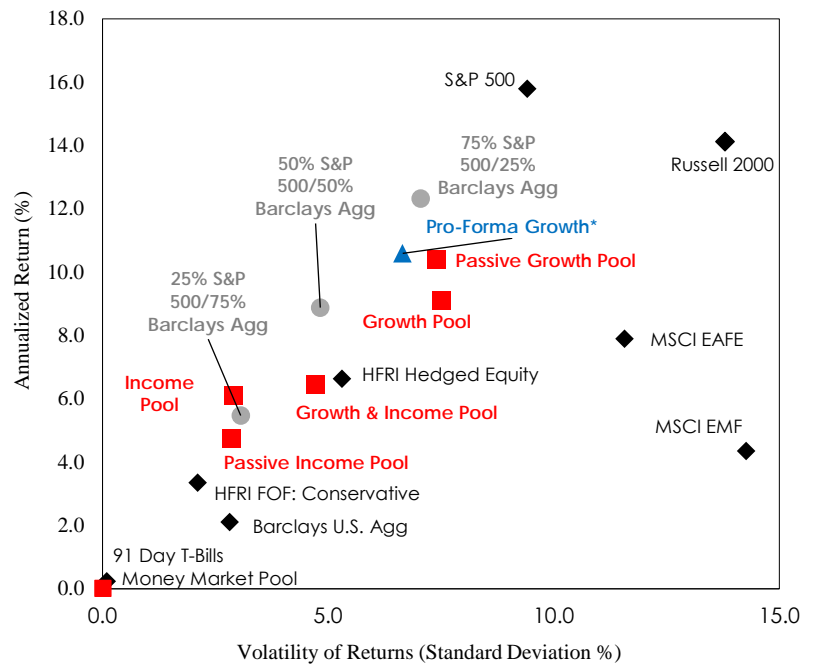
- **The Income Pool rose +0.7%**, and trailed its custom benchmark by -0.1%. Traditional managers lagged the fixed income benchmark this month.
- **The Passive Income Pool rose +0.5%**, and trailed its simple benchmark.
