



Investments Pool Update: Month of January 31, 2018

Markets

- Widespread positive macroeconomic data continued to drive global equities higher in January. US equities enjoyed a strong advance as economic momentum remained robust. Emerging market equities posted strong returns with continued strength in global growth and trade, as well as US dollar weakness, supporting performance.
- Government bond yields rose significantly, reflecting higher growth and inflation expectations after the US tax reform bill passed in December. Corporate bonds performed well.
- The Bloomberg Commodities Index increased in value, supported by a strong gain from the energy component. The Dow Jones Brookfield Global Listed Infrastructure Index was flat this month.

Performance Commentary for Pools, Past Month

Moderate-Term Pool:

- **The Growth & Income Pool rose +2.2%**, and led its custom benchmark. An overweight position in equities, the top performing asset class, helped boost relative performance.

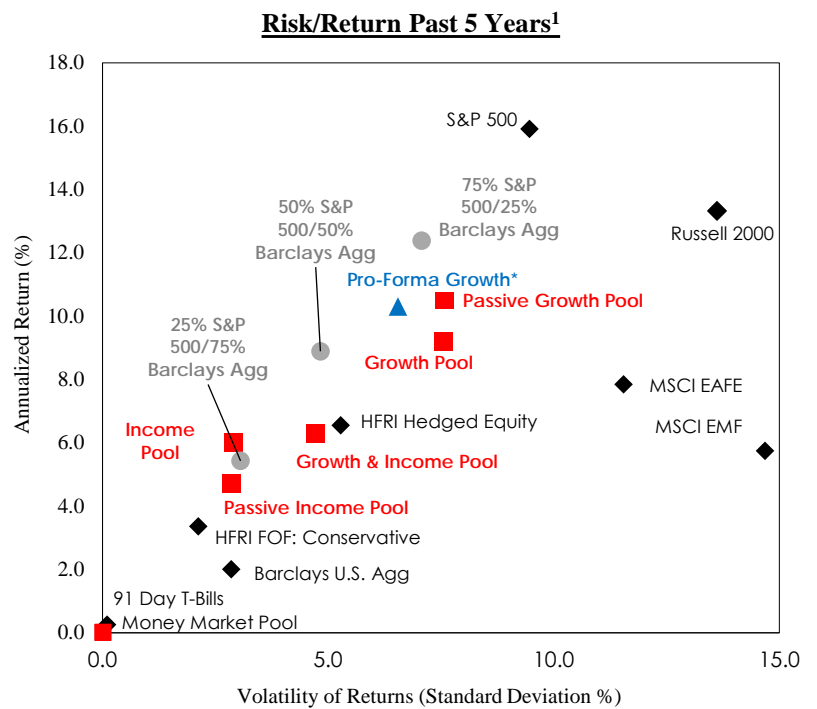
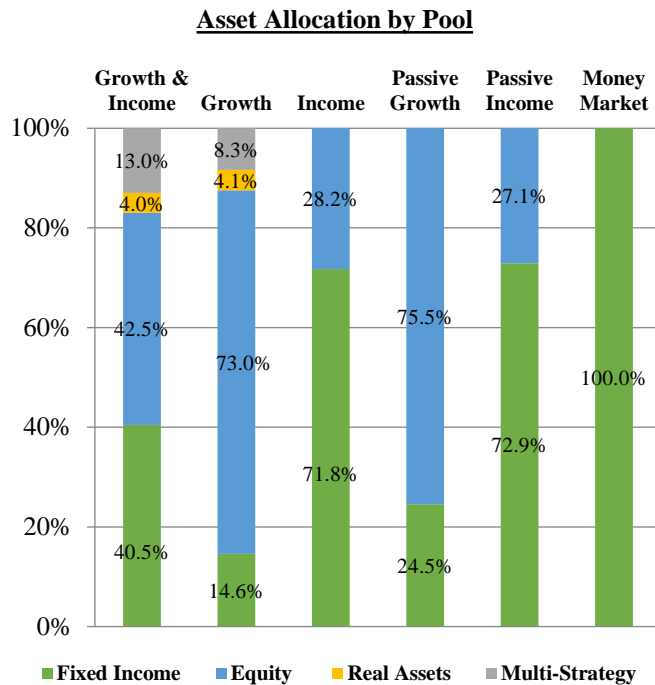
Long-Term Pools:

- **The Growth Pool rose +4.2%**, and led its custom benchmark. An overweight to domestic large cap equity manager Adage added to relative performance. Real Assets managers also added value.
- **The Passive Growth Pool rose +4.0%**, and matched its simple benchmark.

Shorter-Term Pools:

- **The Income Pool rose +1.4%**, and led its custom benchmark by +90 bps. Long/short fixed income managers helped lead the outperformance.
- **The Passive Income Pool rose +0.9%**, and led its simple benchmark by +30 bps.
