A private foundation can easily convert into a donor advised fund at Greater Houston Community Foundation for added ease of administration and estimated reduction in annual operating costs. You can also open a donor advised fund to add to your existing foundation giving strategy, for maximum flexibility.

## Enhanced Tax Benefit for Hard to Value Assets

Donors who wish to contribute real estate, limited partnership interests, and/or closely-held stock during their lifetime receive a tax deduction based on market value if it is given to a donor advised fund.

#### **GRANTMAKING SOLUTIONS**

## **Involving Family Members**

Donors with existing private foundations can establish donor advised funds for their family members, which empowers philanthropic involvement, training, and stewardship. The donor advised fund could be used to pass along the values of giving and engage the next generation of donors.

## Succession Planning

Founders of private foundations state that concerns about succession planning were eased by terminating some portion, or all, of their private foundation to a donor advised fund at the Community Foundation. Our staff can preserve donor intent and the family legacy in perpetuity.

#### Other Enhanced Tax Benefits

Donors with existing private foundations may utilize the higher adjusted gross income limitation of a donor advised fund. Whether the contribution limit is for cash or qualified appreciated assets, there is a six-year period to use the full deduction.

## Access to Grant Making Advice

Private foundation information is public and readily available. Private foundations wishing to make anonymous grants or grants outside their primary focus areas can accomplish those objectives through a donor advised fund.
